

Bike E-Bike Plus

Rental Waiver Agreement

I, _____

Agree to the following rental agreement terms with Bike E-Bike Plus LLC. (BEBP)

1. I accept full responsibility for all electric bikes being rented by Bike E-Bike Plus LLC and hereby agree to pay for any damages to the electric bikes and replace the electric bikes at full retail value if not returned by the agreed date or if the equipment is damaged during rental.
 - I AGREE

2. I agree that I will wear a helmet at all times while riding the electric bike.
 - I AGREE

3. I agree to listen to and follow instructions as to the proper operation of the electric bike from Bike E-Bike Plus and will not commence riding the bike until I am comfortable as to the proper and safe operation of the bike.
 - I AGREE

4. I know that operation of the bike can be risky and dangerous due to many factors including loss of balance, excessive speed on hills, variations in riding surfaces, off pavement terrain, sand, surface water, bumps, etc. I agree to assume responsibility and risk for damage to the bikes and physical injury to myself if anything happens while we are riding the bikes to cause injury to us or the bike.
 - I AGREE

5. I agree that I will only ride the bikes on terrain which is suitable for safely riding the bikes and only I can make that decision. I hereby, for myself and my party release Bike E-Bike Plus LLC and its owners and employees for any liability for any injuries to myself or my party because of my careless and negligent use of the bike, the carelessness and negligence of anyone in my party or our failure to follow Bike E-Bike Plus's instructions for safe operation of the bike.
 - I AGREE

6. I agree that I will not ride the bikes over 25 miles per hour or ride the bikes after excessive consumption of alcohol or other mind-altering substance.
 - I AGREE

7. I understand that our use of the bikes, including safety equipment, cannot guarantee our safety or freedom from injury while riding. I am aware that it is not possible to predict every condition or circumstance under which the bikes or helmets will not operate as intended. I am aware of the risks, dangers and hazards associated with the use of the bikes and I freely accept and fully assume all such risks, dangers, hazards and the responsibility of personal injury, death, property damages and loss resulting therefrom.

8. I state that to the best of my knowledge I have no medical, physical or mental health conditions that would hinder or prevent my active participation in this activity.

9. I confirm that I have read and understood this Rental Agreement prior to signing it, and I am aware that by signing this Rental Agreement I am waiving certain legal rights which I may have against Bike E-Bike Plus. I also agree that if Bike E-Bike Plus starts a legal action because I will not pay something I have agreed to pay for, I will reimburse Bike E-Bike Plus for its attorney's fees and costs incurred by Bike E-Bike Plus's in that effort.
